- (iii) Two years' professional experience in a Library of Standing in Government or Autonomous or Statutory Organisation of Public Sector Undertaking or University or Recognised Research Institutions.

Desirable:

- (i) Master's degree in Library Science of recognised University.
- (ii) Diploma in Computer Applications from a recognised University or Institute

- 10. The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed three years.
