IACS, Kolkata is in looking for energetic, dynamic, young, motivated, and highly qualified prospective facultymembers with requisite experience as per the Recruitment Rules of the Institute for faculty positions in various schools at the levels of Professor, Associate Professor, Assistant Professor, and Faculty Fellow.

The applicants must have an excellent academic record and research experience with high-impact publications and should be able to design *de novo* courses in her/his areas of interest. They must participate in teaching undergraduate/postgraduate/Ph.D. students at IACS, and bring extramural research grants. The faculty members recruited in one School may also have concurrent affiliations with other Schools.

#### 1. HOW TO APPLY:

Interested candidates possessing requisite qualifications and experience are requested to apply electronically to "apply@iacs.res.in", with full bio-data containing the list of publications, description of teaching and research experience, and future teaching and research plans as per the attached format. They should also mention the names of six referees familiar with their work.

Apart from that, the candidates should also send their duly filled-in applications in the prescribed format affixing a passport-size photograph along with requisite documents in support of theireducational qualification, age, and experience in a sealed envelope superscripted clearly "APPLICATION FOR THE POST OF (Name of the post along with advertisement number) addressed to the Director, Indian Association for the Cultivation of Science, 2A & B, Raja S. C. Mullick Road, Kolkata – 700032 by poston (or) before 60 days (75 days for the applicants of North-Eastern regions) from the date of publication of the advertisement in the Employment News.

#### 5. General Information:

- 5.1 Reservation for SC/ST/OBC/EWS will be as per the Policy of the Government of India.
- 5.2 Candidates, who will apply against any of the reserved category posts, viz. SC/ST/OBC/EWS will be considered on the production of valid Caste /EWS Certificate issued by the Appropriate/Competent Authority on the latest prescribed format.
- 5.3 Relaxation of age limit and other concessions will be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Class, Ex-Servicemen, and other special categories of persons, following the orders issued by the Government of India from time to time in this regard.
- 5.4The crucial date for the claim of SC/ ST/ OBC/ EWS etc. status or any other benefit viz. fee concession, reservation, age-relaxation, etc. will be the closing date for receipt of applications.
- 5.5 A person seeking an appointment of based on reservation to OBCs must ensure that s/he possesses the caste/community certificate and does not fall in the creamy layer on the crucial date.
- 5.6 The vacancy position indicated in the Advertisement is tentative. The Institute reserves the right to increase/decrease the number of posts at the time of selection and make appointments accordingly.
- 5.7 The Institute Authority reserves the right to either fill up all the posts or some of the posts or none of them as mentioned in the Advertisement during any stage of the recruitment process without assigning any reason.
- 5.8 The institute is not liable to compensate the applicant for any consequential damage/loss thereof.

#### 6. For OBC Candidates:

- (a) Candidates applying under the OBC category must produce the valid caste certificate in the format provided by DoPT vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and as amended from time to time.
- (b) OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India.
- (c) The vacancies are being advertised in the financial year 2023 2024, therefore, a valid NCL OBC certificate issued after 01.04.2023 will be considered valid. Candidates, who have NCL OBC certificate issued before this period (i.e. 01.04.2023) will not be considered valid for this advertisement. Therefore, OBC candidates must ensure that they have a valid OBC certificate.
- (d) OBC candidate(s) should not belong to Creamy Layer, failing which their candidature will not be considered for the OBC post.

#### 7. For EWS Candidates:

- (a) Application under the EWS category will be considered subject to submission of an Income and Assets certificate in the prescribed format issued by the Competent Authority. Therefore, EWS candidates must ensure that they have a valid EWS certificate application showing the income from all sources for the financial year prior to the year of application as per DoPT OM No. 36039/1/2019-Estt (Res) dated 31.01.2019.
- (b) Candidates who fail to produce a valid EWS certificate will not be considered for reservation under this category.
- (c) As per DoPT OM No 36039/1/2019-Estt (Res) dated 31.01.2019, the crucial date for submitting income and asset certificates by the candidates is the closing date for receipt of an application for the post. Therefore, EWS candidates must ensure that they have an EWS certificate valid for the financial year 2023-24.

#### 8. For SC/ST Candidates:

Candidates applying against vacancies reserved for the SC/ST category should note that they have to submit the Caste Certificate issued by the Competent Authority along with their application.

- 9. The post carries allowances, retirement, and other benefits as per the National Pension System admissible to the IACS Employees.
- 10. Candidature of the application shall be subject to verification of testimonials at any subsequent stage. Incomplete applications and testimonials detected at any stage will be liable for cancellation of candidature.
- 11. Candidates may ensure that they fill in the correct information; Candidates who furnish false information are liable to be disqualified at any stage of recruitment.
- 12. The institute at its discretion may assess the candidates through multiple level screening.
- 13. Only such shortlisted candidates be informed individually via e-mail and the correspondence address provided by them in their applications. The mode of selection/screening for the different posts as decided by the Institute will be notified individually and/or through the website from time to time.
- 14. No TA/DA shall be paid to the candidates for attending the Interview/Presentation session.

- 15. Candidates working on a regular basis in Government Departments/Semi or Quasi Government/Autonomous Bodies/Universities/PSUs etc. or any institution funded by the Government, should send their application through the proper channel. However, those who are forwarding their application through the proper channel are advised to submit an advance copy of the application form well before the closing date.
